DURING THE CURRENT YEAR, LANCASTER FARMLAND TRUST PERMANENTLY PRESERVED 21 FARMS AND 1,255 ACRES OF THE MOST PRODUCTIVE, NON-IRRIGATED LAND IN THE UNITED STATES.
